Ashes must be in a container that is biodegradable with no metal hinges or markings. It can be made from wood, cardboard, wicker or any other biodegradable material. The lining must also be biodegradable with no plastic. Graves can be marked with a wooden plaque only (details on our website). Please do not mark around graves or place ornaments. Only British wildflowers can be planted. We want the site to look as natural as possible.

The Lodge may be used for Services or Gatherings on day of burial at an extra cost – please ask for details.
